The overbroad interpretation of an existing Ohio law by the new Director of Ohio Department of Agriculture [Dorothy Pelanda](#) has been fixed by the legislature ([Senator Bob Peterson](#), [Senator William P. Coley III](#), [Representative Sara Carruthers](#) and [Representative Laura Lanese](#)) and signed by Ohio Governor Mike DeWine July 18th.
